<b>Magistro Family Foundation</b>	<b>\$200,000</b>	★ Evaluate the effectiveness of commonly delivered clinical interventions and develop and evaluate the effectiveness of innovative interventions. Inclusion of cost-effectiveness preferred.
<b>Paris Patla Manual Therapy</b>	<b>\$200,000</b>	★ Advance the therapeutic value of clinical manual therapy interventions and the evidence base for effective manual therapy practice for musculoskeletal conditions.
<b>Paris Patla Physical Therapy</b>	<b>\$100,000</b>	★ Evaluate the effectiveness of commonly delivered clinical interventions and develop and evaluate the effectiveness of innovative interventions. Inclusion of cost-effectiveness preferred.
<b>Acute Care</b>	<b>\$40,000</b>	Studies must be directly related to acute care physical therapy and relevant to acute care in addressing one or more priorities in APTA's Research Agenda.
<b>Cardiovascular and Pulmonary</b>	<b>\$40,000</b>	NEW: Undertake diagnostic, prognostic, rehabilitative or therapeutic interventions or practices that will decrease cardiovascular disease risks and improve cardiovascular and pulmonary outcomes.
<b>Education</b>	<b>\$40,000</b>	Research methods for promoting the uptake of research findings into physical therapy or physical therapist assistant education and design educational interventions to address the gap between evidence and practice.
<b>Foundation</b>	<b>\$40,000</b>	Emerging investigators evaluate the effectiveness of interventions in any relevant physical therapy discipline.
<b>Geriatrics</b>	<b>\$40,000</b>	Address a high-impact priority for improving physical therapy treatment practices for aging adults consistent with the priorities in the APTA Academy of Geriatrics Research Agenda.
<b>Moffat Geriatrics</b>	<b>\$40,000</b>	Evaluate the effectiveness of physical therapists' examinations and/or interventions in geriatric populations.
<b>Orthopaedic Physical Therapy</b>	<b>\$40,000</b>	Emerging investigators explore clinical outcomes of physical therapy practice for patients with musculoskeletal conditions.
<b>Pelvic Health</b>	<b>\$40,000</b>	Advance pelvic health physical therapy, which covers abdominal and pelvic concerns of individuals across the gender spectrum and lifespan.
<b>Snyder</b>	<b>\$40,000</b>	Emerging investigators research the effectiveness of clinical physical therapy services and the development of new interventions that will be relevant and effective.

We have simplified requirements and improved the instructions to help make applying quicker and easier this year. You can work on your online applications until the submission deadline on July 31 at 23:59 ET. None of them require a letter of intent. All research must address at least one priority area in the [APTA Research Agenda](#). The Cardiovascular and Pulmonary grant is new this year. The Jane L. Snyder and education grants are biannual grants.

- [Acute Care Research Grant](#): One \$40,000 grant is available. Membership to the APTA Academy of Acute Care Physical Therapy is required.
- **NEW:** [Cardiovascular and Pulmonary Physical Therapy Research Grant](#): One \$40,000 grant is available. Membership to the Academy of Cardiovascular & Pulmonary Physical Therapy is required.
- [Education Research Grant](#): One \$40,000 grant is available. Membership to the APTA Academy of Education is required.
- [Foundation Research Grant](#): One \$40,000 grant is available. This grant is open for emerging investigators.
- [Geriatric Research Grant](#): One \$40,000 grant is available. Membership to the APTA Geriatrics is required. Research should address priorities in both the APTA and the Academy's research agendas.
- [Moffat Geriatric Research Grant](#): One \$40,000 grant is available.
- [Orthopaedic Physical Therapy Research Grant](#): One \$40,000 grant is available. Membership to the Academy of Orthopaedic Physical Therapy is required. This grant is open to emerging investigators.
